The Floyd Boring Award Department of the Treasury United States Secret Service

The United States Secret Service established the Law Enforcement Assistance Award in 1972. In 1998, the award was renamed "The Floyd Boring Award." Floyd Boring, a now retired agent, was responsible for the initial organizing of the Association of Former Agents of the United States Secret Service (AFAUSSS). His personal integrity, commitment to duty, and personal convictions exemplify the tenets of the Exploring program. The purpose of this award is to recognize Explorers who assist law enforcement agencies with meaningful and exceptional service.

The award pays tribute to the outstanding interest displayed by these young men and women in responding to the responsibilities of law enforcement.

The Award

Two Floyd Boring Awards are conferred. Each consists of a plaque and scholarship presented by the director of the U.S. Secret Service or the director's official representative. The \$2,000 scholarships to the college of choice, which accompany the plaques, are presented by the Association of Former Agents of the United States Secret Service.

Explorers are eligible to compete for the calendar year in which they will graduate from high school. The scholarship money will be directly deposited to the college or university where the Explorer will attend classes.

Nominating Procedure

To nominate an Explorer for the award, the following procedure should be used:

- 1. Complete the Law Enforcement Assistance Award <u>application</u>. Required for consideration: The original and one copy of both the application form and all support materials.
- 2. Submit a brief biographical summary of the nominee and a brief description of meaningful and exceptional service.
- 3. Secure the Learning for Life certification at your local council office.

The Learning for Life representative will determine whether the Explorer is a post participant and whether he or she is qualified for the award. If the nomination is approved by the committee, secure the Learning for Life certification at your local council office and forward to National Law Enforcement Scholarships and Awards, 1325 West Walnut Hill Lane, P.O. Box 152079, Irving, TX 75015-2079.

The National Law Enforcement Committee will furnish the director of the U.S. Secret Service with information concerning approved nominees. The U.S. Secret Service then will select the recipient.

About the United States Secret Service

After the assassination of President William McKinley in Buffalo, New York, in 1901, the U.S. Secret Service was assigned to protect presidents of the United States. Since that time, its protective responsibilities have expanded. Today, the U.S. Secret Service protects

- The president and vice president of the United States
- · Members of their immediate family
- · The president-elect and vice president-elect
- · The widow of a former president until death or remarriage
- Minor children of a former president until they reach age 16
- · Major presidential and vice presidential candidates
- · Visiting heads of a foreign state or government
- Official representatives of the United States performing missions abroad
- · At the direction of the president, other distinguished foreign visitors

Investigative Activities

The suppression of counterfeiting of currency and securities of the United States and of foreign governments is a major responsibility of special agents with the U.S. Secret Service. The agency also investigates the counterfeiting of certain government identification documents and devices.

Each year Social Security checks, retirement pensions, savings bonds, and other federal government disbursements are stolen and forged. The U.S. Secret Service is responsible for investigating these crimes, which result in the loss of millions of dollars annually.

The U.S. Secret Service investigates crimes associated with financial institutions. Its jurisdiction includes bank fraud, access device fraud involving credit and debit cards, telecommunications and computer crimes, fraudulent identification, fraudulent government and commercial securities, and electronic funds transfer fraud.

As a federal law enforcement agency, the U.S. Secret Service participates with other federal, state, and local agencies on task forces targeting specific crimes and/or organized criminal groups.
